This program also provides clothing as needed to children in Montgomery County emergency shelters. It provides elementary school children and schools with book donations and in-school Dr Seuss reading opportunities. This year 6656 students were served.

Scholarship provides scholarships for various types of continuing education, including 4000 dollars to high school graduates attending a 4 year college or university, adults needing to return to education to better their quality of life, adults needing certification courses to obtain employment, and mentally or physically challenged individuals for therapeutic programs. Thirteen graduating high school students received a 4000 dollar scholarship, 1 student received a scholarship to attend community college, 14 received Certification Scholarships, 18 received Continuation Scholarships and 10 received non-traditional Scholarships. Fifty-six individuals received some assistance
